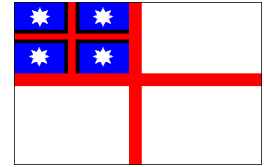

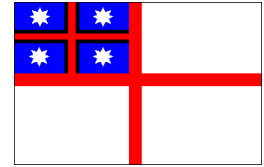
NOTICE TO PRINCIPAL IS NOTICE TO AGENTS FORMAL NOTICE TO WORLD HEALTH ORGANISATION

This is the proclamation of Arikinui Ripekatangi from Tumutumuhenua, Ngati Maniapoto, Ngati Rora, Ngati Koata, Ngati Kahu, Ngati Whatua, Ngati Mahuta, and many other Hapu throughout our Supreme Sovereign Nation of Na-Papatuanuku-Aotearoa Nu Tireni New Zealand also known as Pou Arahi Leader and Prime Minister of the Wakaminenga Maori Government of Aotearoa Nu Tireni New Zealand in rem further proclaim;

This is a formal notice to the Executive Board of the World Health Assembly (WHO), the director general of the

WHO and the president of the European Council you are hereby formally notified that the Wakaminenga Māori government of Aotearoa Nu Tireni/New Zealand does not consent in any shape or form to any type of international pandemic treaty under the WHO or its assembly. Any such construct shall be void ab initio. We, as United Tribes and Hereditary Chiefs, represent the only current lawful government in New Zealand.

As the lawful government of Aotearoa Nu Tireni, recognised under international law since 28 October 1835 and operating under He Wakaputanga 1835 constitution, we instruct the WHO to cease and desist from any intention to apply a global pandemic treaty to our country te Motu Tino Rangatiratanga, the Supreme Sovereign State of Aotearoa Nu Tireni New Zealand to be proposed at the international meeting of WHO 22-28 May 2022. We also support other sovereign states who oppose this international pandemic treaty.

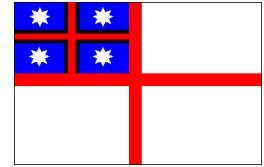
On 14 February 2022 (enclosure) all agents, actors and members of the corporate entity operating under the name NEW ZEALAND GOVERNMENT, and the CROWN CORPORATION, were instructed to stop the intentional harm of all people and to meet with them to hear their requests. They were further instructed by the Wakaminenga Maori Government that;

All mandates pertaining to the Covid-19 Response Act 2021 and the Covid 19 Order 2022 and any other associated orders including MIQ, the vaccine pass are all in breach of He Wakaputanga and Tiriti O Waitangi as they have been implemented without the consent of the Hereditary chiefs, United tribes and Wakaminenga Maori Government of Nu Tireni. Having the rights of English subjects, they were commanded to annul, abrogate, and cancel all present and Covid-19 statutes, restrictions, and orders. This also served as a pre-emptive notice that we reject all attempts of the corporation known as HER MAJESTY QUEEN IN RIGHT of NEW ZEALAND GOVERNMENT AND CROWN CORPORATION, or any other entity or corporation to usurp control of our whenua rangatira by way of any present or future treaties with the World Health Organization, United Nations or any other foreign entities or otherwise.

The current NZ government represented by Jacinda Ardern is an illegitimate government because it is a corporation (SEC CIK #0000216105) listed on the:

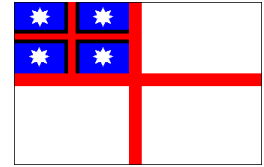
In accordance with the *Clearfield Trust Doctrine*, a corporation does not have any implied right to govern a sovereign people. We hereby register our vote of *no confidence* in the actions or authority of the corporation unlawfully posing as a government in our territory.

The New Zealand Crown Government in their own legislation of the Public Finance (Mixed Ownership Model) Amendment Act 2012. <https://www.legislation.govt.nz/act/public/2012/0045/latest/whole.html> In section 45P-2: They define the Crown: "Crown means Her Majesty the Queen in right of New Zealand".

You are hereby notified that any agreement between the NZ Corporation Her Majesty the Queen in Right of New Zealand and the WHO or any WHO Assembly is now subject to review by the sovereign people of Aotearoa Nu Tireni/New Zealand and its administrative arm, the Wakaminenga Maori Government of Aotearoa Nu Tireni/New Zealand, duly constituted under the internationally recognised Declaration Te Wakauputanga 1835. This unextinguished international law declares in Article 2 that *all sovereign power and authority within our Territories resides entirely and exclusively in the Hereditary Chiefs and Heads of Tribes in their Collective Capacity who also declare that they will not permit any legislative authority separate from themselves to exist, nor any function of governments to be exercised within the said territories unless by persons appointed by us and acting under the authority of laws enacted by us in our Congress assembled*. Again, this means any effort to form such an agreement is *void ab initio* in our jurisdiction.

You are hereby directed to cease and desist any discussions or negotiations with the unlawful Ardern Government, a NZ Corporation, known as *Her Majesty Queen in Right of New Zealand*. The Wakaminenga Maori Government of Aotearoa Nu Tireni reserves the right to discuss/negotiate with any international partner(s)

This notice serves to notify you that we stand firmly in our Sovereignty under settled international law including Te Whakaputanga 1835, and Te Tiriti O Waitangi 1840. We do not consent, and we will not be bound to any construct devised by any organization but ourselves. If you proceed, this shall be seen as an attempt upon our Tino Rangatiratanga, Supreme Sovereignty and an international incident in accordance with He Wakaputanga 1835 Constitution of Nu Tireni New Zealand. We reserve the right to have any proceedings held in a Court of Common Law jurisdiction or our appointed Ture Tikanga Maori Law jurisdiction.
