Rahui - Prohibition

on mRNA BioNTech Medical Gene Therapy and All Derivatives Applies from 17 October 2023

By order of Te Kaunihera Hou Hunga Rongo, Restorative Justice Council - Te Kooti Wakanga Court of Justice of Nu Tireni New Zealand

He Rahui whakatakoto ki raro ki te kawemaitanga, te hoko me te whakamahinga o te hangarau rongoā mRNA BioNTech me nga momo rereke he kino ki te oranga tangata, ki runga ki te whenua katoa o Nu Tireni, e pa ana ki Te Wakaminenga o Te Rangatiratanga me Te Iwi Kotahitanga o Nu Tireni, Te Ture Atua o Te Runga Rawa, Ture Tikanga me He Wakaputanga 1835, kia panui ra ano

Due to concerns that Maori as the native tribal people of New Zealand and other Pacific Islanders were disproportionately targeted for vaccination and including all New Zealanders affected and being aware of the mounting evidence and expert opinion that the mRNA technologies promoted as 'safe and effective' vaccines are injurious to human life a Rahui (Prohibition) has been placed on the importation, sale and use of the mRNA BioNTech medical technology and all derivatives.

The Rahui (Prohibition) is issued in accordance with the Divine law of God, Tikanga and He Wakaputanga 1835, and Te Wakaminenga o Te Rangatiratanga of Nu Tireni, New Zealand and applies to the territorial land mass of the Chiefs and Heads of Te Wakaminenga o Te Rangatiratanga of the United Tribes, Peoples of New Zealand until further notice.

Take note.

The Rahui (Prohibition) has been placed on all mRNA gene therapies following consideration of the evidence heard during case COJ-07-23-0001 held August 27th, 2023, and tribunals TRI-07-23-0001,2,3,4,5, & 6 held September 24th, 2023

All cases dealt with crimes against Tikanga following breaches of Article 6 of The Statute of Waitangi. The first case was brought against 4 senior officials at the heart of the NZ Crown Government's COVID-19 response, and subsequent ones tried the MPs of the 53rd New Zealand Parliament.

What was proven beyond reasonable doubt was that the accused men and women acted individually and collectively against the sovereign authority of Te Wakaminenga o Te Rangatiratanga, the Confederation of the United Tribes of New Zealand to:

- 1. Use acquired legislative authority to abrogate further emergency powers;
- Authorise Advanced Purchase Agreements to fund supply of mRNA technologies whilst disregarding identified harms;

- 3. Allow an Approval process amended in collaboration with Pfizer to facilitate use of the Pfizer BioNTech

 Comirnaty 'vaccine' after ignoring the safety concerns raised in the evaluations by MedSafe. The decision

 by the General Manager of MedSafe to refuse consent for Pfizer was overturned.
- 4. Participate and support events that used sophisticated techniques of behavioural influence to create a perception that the vaccine was "safe and effective" disregarding the 58 safety issues that were pending correction, amendment, and modification by Pfizer.

On September 27th, 2023, Te Kaunihera Hou Hunga Rongo Restorative/Justice Council of Te Kooti Wakanga/Court of Justice of Nu Tireni New Zealand issued a decision to place a rahui (prohibition) on the importation, sale and use of the mRNA gene therapy and all other derivatives within the territories of the United Tribes of Nu Tireni, New Zealand.

All and any breaches of this Rahui (Prohibition) will be considered a serious crime against Te Wakaminenga o Te Rangatiratanga of the United Tribes Peoples of New Zealand, punishable by an extensive period of imprisonment and up to 100 percent liquidation of assets and the possibility of being investigated and subsequently prosecuted for crimes of genocide and crimes against humanity.
