## THIS PROCLAMATION REAFFIRMS AND CONFIRMS TE WAKAMINENGA O TE RANGATIRATANGA O NGA HAPU UNITED TRIBES AND PEOPLES OF NU TIRENI NEW ZEALAND AS THE DE JURE SOVEREIGN GOVERNANCE BODY OF THE STATE OF NU TIRENI, NEW ZEALAND IN ACCORDANCE WITH OUR CONSTITIONAL LAW OF HE WAKAPUTANGA 1835 DECLARATION OF INDEPENDENCE. PROCLAIMED AT RUKUHIA, WAIPA ON 13 JANUARY 2024

- 1. We, Te Wakaminenga, o Te Rangatiratanga o Nga Hapu United Tribes and Peoples of Nu Tireni New Zealand by the powers and authority invested in us gathered at Rukuhia, Waipa to make proclamation on this day 13 January 2024.
- 2. In accordance with our unextinguished constitution of He Wakaputanga 1835, Declaration of Independence we reaffirm and confirm Te Wakaminenga o Te Rangatiratanga o Nga Hapu United Tribes and Peoples of Nu Tireni New Zealand as the only lawful supreme, de jure governance body of the State of Nu Tireni New Zealand that has powers and authority to carry out governance duties for all New Zealanders.
- 3. Since 1840, in violation of our constitutional law of He Wakaputanga, 1835, the New Zealand Crown defacto Government under the British Crown, their Principals and Agents, have repeatedly committed crimes including wars, land confiscation and displacement. Initially these actions were directed against the first nation Tangata Maori of Nu Tireni. Recently they have colluded and conspired with external global agents including the World Health Organisation (WHO), the United Nations (UN) and the World Economic Forum (WEF), to commit the most heinous of crimes against all the people of Nu Tireni New Zealand be they Maori, Pakeha or Tauiwi (immigrants) known collectively as New Zealanders.
- 4. Under the guise of a Public Health Emergency using acquired authority to pass legislation such as the Covid 19 Response Act 2020, the New Zealand Crown defacto Government, its Principals and Agents coerced, cajoled, and forced New Zealanders to consider injecting a proven harmful, experimental drug into their bodies known as mRNA gene therapy. Rises in serious injuries and the deaths of thousands of New Zealanders followed. Furthermore, the New Zealand Crown defacto Government, their Principals and Agents have agreed to a global pandemic treaty against our declaration of independence He Wakaputanga. Elsewhere they have colluded with global agencies to weaponize migration, use weather modification to alter natural



weather patterns, and create economic insecurity, resulting in loss of freedoms and human rights for all New Zealanders. Such actions are part of a concerted, long-term effort directed to achieve global depopulation.

- 5. All obligations upon the sovereign Native Chiefs and New Zealanders since 1840 have been unlawfully imposed by the New Zealand Crown defacto Government and its Principals and Agents. Since they relied on the voided Treaty of Waitangi, also known as Te Tiriti o Waitangi 1840, any and all obligations to them are likewise void. Under the protection of He Wakaputanga immunity from prosecution by the New Zealand Crown defacto Government applies to all peoples. Conversely, the New Zealand Crown defacto Government, its Principals and Agents are liable to prosecution for any and all breaches of Tikanga. New Zealanders who transition to the valid, lawful He Wakaputanga jurisdiction are protected from all harms and criminal actions committed against them.
- 6. We raise serious concerns regarding actions by Te Wakaminenga ki Waitangi Taumata. For many years their focus on local issues rather than what faced Congress at a national and international level unduly influenced Te Wakaminenga o Te Rangatiratanga National Congress hui. Serious operational failures resulted including the demise of Southern tribes' attendances at hui in recent times. The enforcement of our sovereign law of He Wakaputanga was prevented depriving us of recourse to lawful remedies. We regard these actions as a breach of He Wakaputanga giving rise to no confidence in Te Wakaminenga ki Waitangi Taumata to host further National Wakaminenga Congress hui regarding issues confronting Congress as a whole.
- 7. Te Wakaminenga o Te Rangatiratanga o Nga Hapu Untied Tribes and Peoples of Nu Tireni New Zealand is the collective governance body led by hapu and community leadership representatives, chosen by the people from their respective regions. As such governance of the People, by the People and for the People is available to all New Zealanders.
- 8. As its first call of duty on this day, Te Wakaminenga o Te Rangatiratanga o Nga Hapu United Tribes and Peoples of Nu Tireni New Zealand also known as Te Wakaminenga National Congress of Nu Tireni New Zealand reformed and reinstated to its rightful position as the supreme de jure governance body, invokes its sovereign powers and authority and without equivocation and on behalf of all the people of New Zealand hereby removes the New

Zealand Crown defacto Government permanently from their unlawful occupation of Nu Tireni New Zealand. All lawful prior means to enforce criminal judgements against the entity known as the New Zealand Crown defacto Government and including its Principals and Agents are endorsed.

- 9. The Maori Government as appointed in 1983 in Waitangi to undertake the national administrative role for Te Wakaminenga o Te Rangatiratanga o Nga Hapu United Tribes and Peoples of Nu Tireni New Zealand will remain in place to implement the laws enacted by Te Wakaminenga in Congress assembled, in accordance with article 2 He Wakaputanga 1835.
- 10. Te Wakamienga o Te Rangatiratanga affirms He Wakaputanga as a sacred covenant of Te Rangatira o Nga Hapu United Tribes and Peoples of Nu Tireni New Zealand and we therefore reinstate its true intention to unite our country as one people in justice, peace, security, and prosperity for all New Zealanders in accordance with God's Divine Biblical Law and Te Ture Tikanga, Tika (Correctness), Pono (Honour) me Te Aroha (and Compassion).

Signed this day 13 January 2024 by the sovereign Peoples of Te Wakaminenga o Te Rangatiratanga o Nga Hapu, United Tribes and Peoples of NuTireni New Zealand.
