



US congressional records still list He Wakaputanga as the legal jurisdiction in New Zealand.

James Clendon was the first American Consul appointed in 1838 to New Zealand, he also signed as a witness to our Declaration of Independence.

The unextinguished Declaration of Independence declares the original authoritative government to be the Wakaminenga National Congress of the *Sacred Confederation of Chiefs* who are the sole, exclusive and lawful sovereign of Nu Tireni, New Zealand, absolutely without reservation and independent of the occupying New Zealand defacto Government

In 1840 the native Maori Chiefs were coerced into signing a treaty with the British Crown known as the treaty or tiriti (Maori language translation) of Waitangi, a failed attempt to take New Zealand's sovereignty that was entrusted by the Maori tribes to their Chiefs, however it has been used by the New Zealand Government to maintain their unlawful power and control over our land and resources.

The American constitution provided the model upon which the Maori Chief's created New Zealand's first and only written constitution in order to claim their existing independence at the time, establish lawful government, and to unite all New Zealanders living within our free and prosperous economy.

Since the signing of the 1840 treaty or tiriti of Waitangi, the Maori people and New Zealanders have suffered many injustices at the hands of the British Crown and the New Zealand defacto government.


