

Wakaminenga Maori Government Under He Wakaputanga 1835, Nu Tireni/New Zealand - Rejection of Amendments to the International Health Regulations

He Wakaputanga 1835 Declaration of Independence, confirms the sovereign powers and authority and tino rangatiratanga of the Wakaminenga Congress of Hereditary Chiefs and Heads of Tribes of the United Tribes and Peoples of Nu Tireni/New Zealand.

All people who live in Nu Tireni/New Zealand, who abide by Tikanga in accordance with the jurisdiction established under He Wakaputanga, are free and protected from all foreign interference, including yours.

The Wakaminenga Maori Government as the administrative arm of the Wakaminenga National Congress rejects the imposition of any and all foreign instruments, mandates, or health governance structures that undermine the sovereignty, customs, Tikanga and those that impinge on the inherent rights of our people on our lands.

No agreements, regulations, or amendments have any lawful standing within the territories under the jurisdiction of the Wakaminenga Maori Government unless explicitly agreed to by our rangatira and must accord with Tikanga and processes of Tiaki Hauora, Health Council of Nu Tireni, New Zealand.

This includes those of the WHO especially any proposed amendments to the International Health Regulations (IHR), which are opposed.

For clarity and to dispel any doubt the amendments to the IHR are outright rejected.

Further action to impose the influence of the WHO on the people of Nu Tireni/New Zealand by you or any of your associates or representatives will lead to you/they/them being held personally liable which will lead to you/they/them being investigated with the absolute possibility of prosecution through Te Kooti Waakanga nui, Hohou Te Rongo, Supreme Court of Restorative Justice.
